

THE TUNBS.

THE HARD IRANIAN ATTITUDE IN YOUR TELNO 1641 STRUCK US AS DESIGNED TO IMPRESS THE VISITOR AND NCT NECESSARILY TO RULE OUT SOFTER ATTITUDES ON PARTICULAR PROBLEMS (COMPARE THE ATTITUDE OF THE MINISTER OF COURT AND ACTING FOREIGN MINISTER TO THE TUNBS IN PARA 5 OF THE SAME TELEGRAM). BUT IF THE IRANIANS TOOK THE LINE IN PARA 2 OF DUBAI TELNO 494 TO BAHRAIN — AND THE TONE OF THEIR—23 EARLIER DRAFT DOES NOT MAKE THIS IMPROBABLE — THEY WILL ONLY HAVE THEMSELVES TO BLAME IF RAS AL KHAIMAH TAKES COVER UNDER CUR CONTINUING PROTECTION AND IF THE WHOLE PROBLEM, IN CONSEQUENCE, IS THROWN BACK INTO ITS ORIGINAL IMPASSE.

- 2. YOU HAVE REPEATEDLY MADE IT CLEAR TO THE IRANIANS OVER RECENT YEARS THAT IRANIAN ACTION DESIGNED, OR LIKELY, TO FACE BRITAIN WITH A CHOICE BETWEEN IRAN AND THE GULF ARABS COULD NOT RESULT IN OUTCOMES SATISFACTORY EITHER TO IRAN OR BRITAIN. WE FIND IT AT LEAST SURPRISING THAT THE IRANIANS SHOULD HAVE TAKEN THIS LINE WITHIN TEN DAYS OF THE SHAH'S VISIT TO KING FAISAL, WHOSE CAPACITY TO ASSIST OVER SUCH PROBLEMS IS NATURALLY LIMITED AND CAN HARDLY BE INCREASED BY SUCH IRANIAN TACTICS.
 - 3. LIKE THE POLITICAL RESIDENT WE WOULD PREFER TO KEEP OUT OF THESE EXCHANGES. BUT WE THINK THAT YOU SHOULD, UNLESS YOU SEE OBJECTION, TAKE STEPS TO ASK THE IRANIANS FOR THEIR ACCOUNT OF THE MEETING WITH KHALID: YOU SHOULD INDICATE THAT WHATEVER THE IRANIANS SAID TO THE RULER OF RAS AL KHAIMAH'S SON SEEMS TO HAVE BEEN TAKEN AS A BULLYING ULTIMATUM OVER SOVEREIGNTY AND TO HAVE CONFIDENTIAL /GIVEN
